Respondent

The present incident is placed in the land of Wano, a democratic republic nation with the largest youth population. The country is culturally vibrant and discerning indulgence of the youth in social media and an enormous spike in the count of content creators' day by day.

Republic of Wano is one of the largest democracies in the world. More than half of the area of Wano is surrounded by ocean and the rest shares boundary with mountain ranges. The country hosts people from various regions and cultural backgrounds maintaining a secular belief for all its citizen. The Constitution of Wano imbibes socialistic and democratic republic values in its Preamble. Moreover, the Preamble enshrines the development of scientific temper amongst its citizens. The Constitution of Wano, under Part III, has enshrined the fundamental rights that provides right to life and personal liberty to every individual of the country. The Constitution also bestows upon its citizens; among other rights, the fundamental right to practice a profession with reasonable restrictions so as to not challenge the sovereignty, integrity, and public order of the nation.

Robin, a seventeen-year-old girl, lives in the state of Zou in Wano. She is a dedicated student with a strong interest in social interaction and building connections. Curious and outgoing, she thrives in group conversations, enjoying the exchange of ideas and learning from others' perspectives. Her natural communication skills make her an active participant in school activities, often bringing people together, whether in the classroom or at events. Through her love for socializing, she has developed a keen understanding of people and deeply values the growth that comes from shared experiences.

On 15th June, while she was surfing social media, she got to know about an application Hubbify, a dynamic social media platform designed to bring people closer through the power of photos and videos. It's a public domain where an individual can only create a public profile, the application does not have any facility of private profile. With Hubbify, users can capture, share, and discover moments from all around the world, building connections and engaging with a vibrant global community. Whether it's showcasing your creative side, sharing life's memorable moments, or exploring content from diverse cultures, Hubbify makes social interaction more meaningful and visually captivating.

On 18th June, Robin made her first post with a collage of multiple photos of her. Since she was constantly active and regularly posted herself on Hubbify, she made a lot of friends and followers with whom she used to interact socially.

With the time she gained popularity and her followers surged. Though these interactions draw a lot of glamour and spotlight, it also led to

unwanted attention on media. On 21st August Robin was approached by one of her anonymous followers, Hughie. In their first interaction Hughie introduced himself as one of her fan and a new comer director who wanted to cast her for an advertisement, which was instantly accepted by robin as it was an opportunity to address her social hunger for popularity.

Robin and Hughie began their conversations regarding the terms and policies of advertisement, which kept them in constant touch on Hubbify. Robin was eager to learn more about her role and the specifics of the advertisement. During their discussions, Hughie mentioned that he had numerous contacts and connections within the industry and the central ministry, emphasizing that these relationships could be very beneficial for her. These interactions continued for several weeks."

On October 7th, after a series of engaging conversations, Hughie proposed to Robin through a message: 'Hey, I need to say something. It's too early, but the truth is, I have feelings for you. I genuinely wanted to confess because I've been following you for a while now. To be honest, approaching you in the first place was driven by this feeling, I love you.'

After reading the message, Robin politely declined his proposal, explaining that she wanted to focus on her studies and career advancement. However, Hughie persisted in trying to convince her to accept his feelings. When he attempted to pressure her by using his advertisement offer as leverage, Robin became furious. She decided to withdraw from the advertisement project entirely.

In response, Hughie messaged her: 'That's sad, Robin. I had higher expectations and was really looking forward to us being together. But you're very rude and egoistic. All I can say is, all the best for your future.'

As a result of the incident, Robin was deeply upset and in despair, choosing not to log in to Hubbify for several days.

On the morning of October 13th, she received a call from her close friend, Sia, who informed her about multiple photographs and videos of Robin being circulated on the hubbify platform. This alarming news sent Robin into a panic. Shocked, she immediately logged into her hubbify account, only to discover that numerous photos and videos of her were being spammed across the internet. These were deepfake creations, containing explicit and obscene content, falsely attributed to her.

Out of the bunch of comment on the contents, one of the loathing comments of a social activist Dr. Hanumant Rai grasped her attention where comment was trending with #PAAP (Protect and Adire Principles), in which Dr. Rai commented on the uprising concern regarding young generation's hunger to get popularity and always be in spotlight on the price of our cultural ethics & morality that surely leading the youth to various unwanted distraction. Dr. Rai also showed his worry towards the vulnerability of youth about the incidents like was happened with Robin. Adding on he commented *"We should not support such vulgarity of such desperate creators like Robin they really do not deserves to dwell in the civilized society"*.

Following this, a massive media uproar ensued. A large group of people, offended by the explicit content, began trolling Robin online and condemning her presence. The outrage escalated to the point where individuals gathered outside her residence to express their anger.

Overwhelmed by the situation, Robin had a mental breakdown and shared the incident with her parents. They consoled her and immediately reported the offensive content circulating on the internet. Later that day, Robin and her parents went to the cybercrime cell to file a formal complaint. On their way back home, they were met with public outrage once again. The crowd aggressively abused her parents, and in an appalling act of hostility, some individuals threw black paint on Robin while yelling '#PAAP'.

Hubbify, addressing the report made by the parents of Robin removed the obscene content from the app on the same day yet the deep fake content was already spread out on different Medias all over the internet. Resulted in a situation where she found herself with mental breakdown and grave sore of losing her innocence and being targeted victim of character assassination.

Next morning at around 11:30 Am as it was too late, robin's parents went her room where they found Robin dead hanged herself. Parents were horrified and in the scenario of panic and shock they called police. During investigation they reported it as a matter of suicide after the confirmation of forensic experts. On the request of parent's police also tried to approach Hughie for the interrogation purpose but it was found that Hughie left the country in a hurry, police had no lead of his current location.

Later on, 15th October Robin's parents logged an FIR against Hubbify, Hughie & Dr. Rai under the provision of WNS (Wano Nyaya Sanhita), 2023, IT act, 2000, POCSO act, 2019 Since Robin's family belongs to schedule caste, families & friends of Robin's father from SC/ST community came together to console Robin's parents and raised their voice, asking for justice.

They protested that this matter should be transferred to CBI for quick and fair addressal. But despite the protest, state did not transfer the matter to CBI. On third day morning, After the heart-breaking incidence of the loss of their daughter her parents approached the court of law and the proceeding against Hubbify app and Dr. Hanumant Rai in the POCSO court under the provisions of POCSO ACT, 2019, IT Act, 2002 & WNS (Wano Nyaya Sanhita), 2023 initiated, under the strong belief that because of the mental agony caused by the accused they lost their beloved daughter. Further, hours later tired from continuous protest robin's father went home to take his lunch meanwhile, provoked by the decision of state protest took an aggressive turn resulted in mob lynching, in which twelve to fifteen people lost their life.

Police immediately arrested Robin's father at 12:00 PM from his home without considering his plea that he was not present at the time of the incident. The police presented the accused father next day on 2:00 PM in front of the magistrate. State took action against the Robin's father for initiating such protest. Charges were framed and Robin's father was convicted by the court, meanwhile in the morning matter instituted in POCSO Court also turned down by the court ordering against the prosecution considering the fact that court didn't find any strong and reliable evidences to establish the case of prosecution;

- The terms and condition of Hubbify were crystal clear that it's a public application.
- Media on this application are subject to public notice.
- The fact that Hubbify took immediate action on the report of obscene contents.
- The concerned showed by Dr. Rai were in good faith and in the exercise of his right of freedom of speech and expression.
- No direct evidences found to hold the culpable involvement of Hughie and he was not prosecuted as he was outside the country.

Unsatisfied by the judgement of POCSO Court and the conviction of Robin's father. Robin's parents filed appeal before the High Court of Zou. High Court, after careful consideration, chose to uphold the lower court's decision and the conviction charges of Robin's father without any alterations.

Additionally, they declined to grant a certificate for further appeal to the Supreme Court. This indicates that the High Court found the evidence and legal arguments presented by the prosecution to be insufficient to reverse the decision.

Aggrieved from the decision of High Court, Robin's father approached the Supreme Court of Wano under a joint Special leave Petition for both the matters since, identity of sources that leaked the obscene content are still unknown.

LEGAL ISSUES

Issue 1. Whether the joint Special Leave Petition is Maintainable before the Hon'ble Supreme Court?

Issue 2. Whether the acquittal of Dr. Hanumant Rai, the non-arrest of Hughie, and the decision to allow Hubbify to continue its operations without legal consequence are legally justified, given the charges framed against them and the surrounding circumstances?

Issue 3. Whether the conviction of Robin's father, in light of his absence during the protest's escalation, can be legally justified under the applicable laws?

COMMENT

- This incident occurred in the state of Zou.
- Hubbify is the original company of the land of Wano and operates throughout the globe.
- Hughie's father holds the post of minister in the central government and he is a very renowned person.
- Hughie and Dr. Hanumant Rai shares a relationship as Dr. Rai is Hughie's uncle & both of them are the resident of Skypiea, which is another state in the land of Wano.

NOTE

1. The laws of the Wano are Pari Material with laws of the India. The Hon'ble Supreme Court of Wano considers the leading common law precedents as being highly persuasive. Hence, all the relevant ancient, modern, texts of Indian laws may be referred for arguing the case.
2. Preposition consist Three legal issues for adjudication before the Hon'ble Supreme Court, additionally the participants are free to frame other issues of their choice.
3. Participants are requested to argue on the side of the Petitioner as well as on the side of the Respondents before the "Hon'ble Supreme Court of Wano" pertaining to the above case and further elucidate the arguments with appropriate case laws and inputs.
4. This Moot Problem has been formulated solely for the purpose of this competition for furthering the academic exercise only.





ARTICLE 1 – TEAM COMPOSITION



1. Each team shall consist of 3 members. This number cannot be modified under any circumstances. In case there is two member team then such team shall not be evaluated for best researcher.
2. In case 3 members are participating then there shall be 2 Speakers and 1 Researcher in each team.
3. Each team will have a team code. Teams should not disclose their identity or that of their institution or city, etc., under any circumstances during competition and such disclosure shall invite penalties including disqualification from the competition directly. The decision for the same shall be at the discretion of the organizers.
4. Maximum number of teams for the competition shall be 50 and selected on the basis of first come first serve



ARTICLE 2 – DATE AND VENUE



The said competition will be held from **01-03 March, 2025** at the Faculty of Law, Jagan Nath University, Sitapura Industrial Area, Near Chokhi Dhani, Jaipur, Rajasthan 302022.



ARTICLE 3 – DRESS CODE



- 1. Male:** Advocate's attire (black blazer, black trouser, black formal shoes and white formal shirt with black tie) is compulsory. Participants are expected to make their own arrangements regarding the same. Not abiding by the said rule can lead to direct disqualification and the organizing committee will have complete discretion regarding the same.
- 2. Female:** Advocate's attire (black blazer, black trouser, black formal Belly and white formal shirt with black tie) is compulsory. Participants are expected to make their own arrangements regarding the same. Not abiding by the said rule can lead to direct disqualification and the organizing committee will have complete discretion regarding the same.



ARTICLE 4 – ELIGIBILITY CRITERIA



1. Students pursuing any three-year or five-year integrated course of the LL.B. degree from any recognized Law college/ University in India by UGC/BCI are eligible to participate.
2. Participant shall carry their college identity card for the purpose of identification during the said competition.

The said competition shall be in ENGLISH LANGUAGE only. Use of vernacular language by the participants during the said competition is prohibited.



ARTICLE 7 – GUIDELINES FOR MEMORIALS



Written Submissions Structure: The written submissions must contain the following contents:

1. Cover Page
2. Table of Contents
3. List of Abbreviations
4. Index of Authorities
5. Statement of Jurisdiction
6. Statement of Facts
7. Issues Raised
8. Summary of Arguments
9. Arguments Advanced
10. Prayer

Team Code: The team code must be affix to the top right corner of the cover page. The code must be succeeded by the side for which the written submission is prepared

Cover page colour :

1. Petitioner- Blue
2. Respondent- Red

Margin: The written submission must maintain an equal margin of 1 inch on all sides. Non-compliance will result in a penalty of 1 mark per side of written submissions. Font, size and line spacing: The text font should be Times New Roman or Garamond, size 12 and must be in 1.5 line spacing. Non-compliance will result in a penalty of 0.5 marks per incorrect format of font, size and line spacing with a maximum of 2 marks per page of the written submissions.

Footnotes: The footnotes must be in Times New Roman or Garamond font, size 10 and singly spaced. There should be double line spacing between two footnotes.

The Bluebook: A Uniform System of Citation (20th Edition) should be followed throughout the written submission throughout. Non-compliance will result in a penalty of 1 mark per page. Substantive/Speaking footnotes are strictly prohibited. Non-compliance will result in a penalty of 1 mark per substantive citation.

Header and Footer: The font used for the header/footer, if any, shall be Times New Roman or Garamond, size 10, 1 spacing. Non-compliance will result in a penalty of 1 mark per page of the written submissions.

Page Limit: The memorial shall not exceed from 40 pages and minimum shall be 25 pages. No annexures, photographs, exhibits, etc. should be added to the written submission. The written submission shall be marked on a score of 100 marks.



ARTICLE 8 – SCOUTING



1. Teams will not be allowed to observe the oral rounds of any other teams. Scouting is strictly prohibited. Scouting by any of the teams shall result in disqualification, as per the discretion of the organizers.
2. Any participating team can file a written complaint to the organizers, regarding the incident of scouting. The organizers decision shall be final.
3. The researchers will sit with the speakers at the time of orals and shall not attend the rounds of any other team participating in the said competition.



ARTICLE 9 – ROUNDS



Registration for the preliminary rounds and draw of lots will be held on **01 March, 2025**. The preliminary rounds will be held on **01 March, 2025** comprising of two (2) rounds for each team. In the Preliminary rounds, each team shall appear from both petitioner and respondent sides.

Eight teams shall qualify for the quarter finals.

The quarter finals round will be held on 02 March, 2025.

The semifinals round will be held on 02 March, 2025.

The final round will be held on 03 March, 2025.



ARTICLE 10 – ORAL ROUNDS



In the Preliminary and Quarter final rounds the time slot for each round shall be as follows:

Opening Statement on behalf of Petitioner	5minutes
Opening Statement on behalf of the Respondent	5minutes
Arguments by Petitioner	10minutes
Arguments by Respondent	10minutes
Prayer from Petitioner	5minutes
Prayer from Respondent	5minutes

Therefore, the petitioner will get a total of 20 minutes and the respondent will get a total of 20 minutes in the preliminary rounds. Each speaker shall have to argue at least on one issue. This rule shall apply to the Two (2) rounds comprising the preliminary round. Each speaker shall deliver either the opening statement or the final argument in each round.

In the semifinals and final round, the time slot shall be as follows-

Opening Statement on behalf of Petitioner	5minutes
Opening Statement on behalf of the Respondent	5minutes
Arguments by Petitioner	15minutes
Arguments by Respondent	15minutes
Prayer from Petitioner	5minutes
Prayer from Respondent	5minutes



ARTICLE 11 – JUDGING CRITERIA



The parameters for judging are:

1. Knowledge of facts.
2. Logic and clarity in reasoning.
3. Persuasiveness and deference to court.
4. Proper, articulate and systematic analysis of the issues arising out of facts.
5. Understanding of the laws and procedure.
6. Ingenuity (ability to argue by analogy from related aspects of law) or knowledge of the relevant provisions relating to penal laws.

Note:

Both the teams must be aware about the appellate procedure followed by the courts. Cumulative eight highest scorer teams in both preliminary round, Shall be selected for quarter finals. After that, there will be knockout rounds from quarter finals to final.

ARTICLE 13 – CERTIFICATES

ARTICLE 16 – MISCELLANEOUS



Case laws that the parties wish to rely on at the time of final arguments shall be submitted in three copies in form of a compendium (one for the judges, one for the other side and one for itself). The source of judgements should be from a verified database like SCC Online, Manupatra etc.

Opening statement of the petitioner shall be from facts and the issues raised. It shall be necessary to point out the supporting material from the fact sheet herewith provided to sustain the arguments. As far as the respondent is concerned, the opening address shall require them to point out the allegations against them.

Judges are at liberty to ask questions to the participants on relevant points of law which may arise as per the fact sheet arising during the conduction of proceedings, in order to test the participant's knowledge of the relevant provisions relating to penal laws.

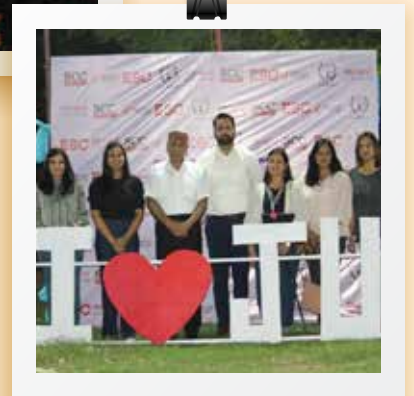
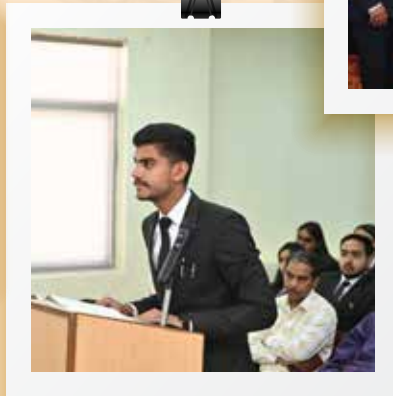
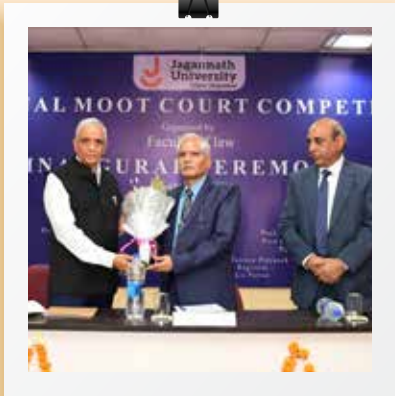
