


**A copy of Resolution no. 37.05 passed by the Board of Management, Jagan Nath University, Jaipur held on June 22, 2019.**

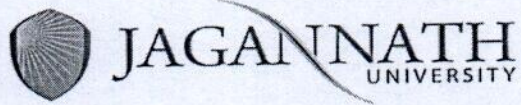


**A copy of Resolution no. 34.05 passed by the Board of Management, Jagan Nath University, Jaipur held on May 26, 2018.**

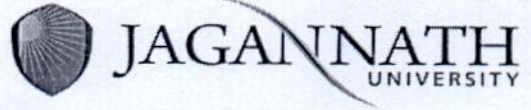
The Board also appreciated that the University is starting B.Tech (Aerospace), B.Sc. (Aviation), BBA (Retail) and other new courses.
