Claim

Jagan Nath University has a well-defined seed money policy that is an integral part of the Research Policy. Seed money is granted to the faculty members to prepare research proposals for external funding agency (government/industry). Research proposals for seed money are invited from the faculty members every year. All the applications are considered by expert committee. Suitable projects are sanctioned seed money on the recommendation of the expert committee and the Director, IQAC. Progress in the project work is monitored to ensure and maintain the quality research work in the project. Majority of projects sanctioned are in process and are delayed due to Covid-19 pandemic. However, three project sanctioned are complete. The University has provided Rs 25.278 Lakhs as seed money to its faculty members for research projects during last five years. All the details about seed money projects have been provided and audited statements of income-expenditure accounts uploaded. The University claims full credit in the metric 3.1.2.
