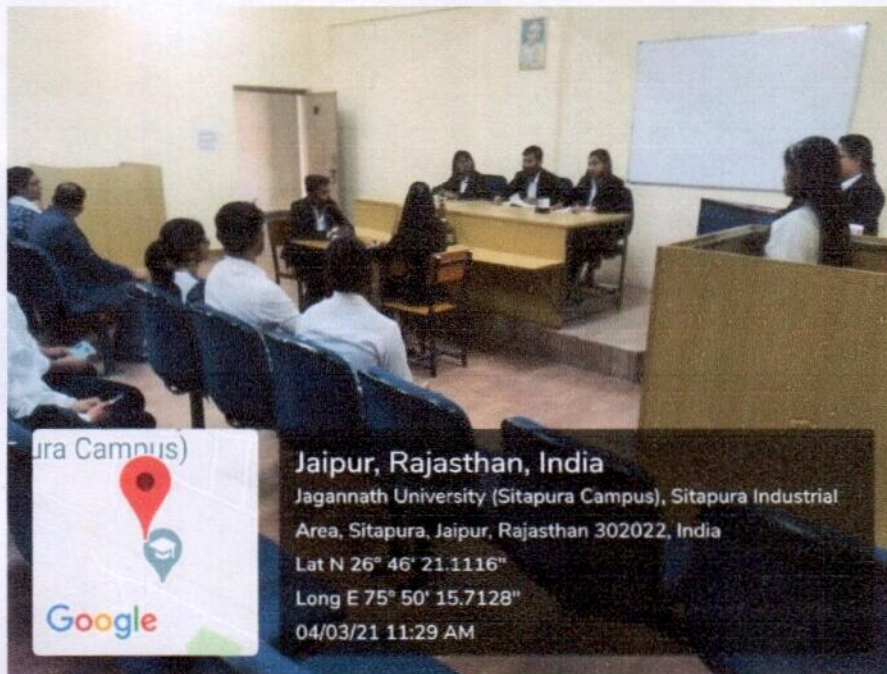


## Moot Court

In a moot court new knowledge and experience are acquired by combining previous experience, legal information and practical uses. It connects the law students to real court experience. The moot court experience for law students develop the ability to identify the legal subject, arrange various law materials, prepare plead arguments, duties of an advocate, nature of the judicial system of India and answering the questions raised by other side, facing cross examination, answering without losing temper. Moot Court also develops the art which will follow the student for the rest of his/her professional career.

Inter-class and inter-semester moot court competitions and mock trials are part of our regular syllabus. We have a well equipped computer lab and Manupatra excess for the help of the students and eminent faculties are there for the help. In the 10th semester no regular classes are conducted in the college and students have to attend courts and do internships. This makes them experience the practical aspect of law education. The main focus of our law program is to make our students understand the practical aspect of legal education by way of moot courts, mock trials, attending courts and doing internships on a regular basis. Through this practical exposure the students become confident and well prepared for practicing as a lawyer and can appear in various competitions.

**DETAIL REPORT OF JAGANNATH UNIVERSITY NATIONAL MOOT COURT  
COMPETITION-2017 (April 8-9, 2017)**

Faculty of Law, Jagannath University, Jaipur under the Mentorship of Honorable Chancellor Dr. Amit Gupta, Mr. Manish Gupta, Mr. Deepak Gupta, Honorable Vice Chancellor Prof. (Dr.) V. K. Agarwal and Prof. (Dr.) Mahendra Tiwari Dean (Law), organized a Moot Court Competition in order to enhance the legal skills & augment knowledge of law. Faculty of Law executed the plan with the help of Students Moot Court Committee and finally organized the National Moot court Competition- 2017 on *April 8-9, 2017 at Sitapura Campus.*

The students Moot Court Committee drafted the Moot court problem, Rules, Regulations for the Moot Court Competition and invitation letter, which was uploaded on the Website of Lawctopus. After uploading the Moot problem overwhelming response was received from various National Law Schools and Top leading law Institutions from across the country.

Total 54 teams from reputed Law Institutions and Universities across the country registered for this competition, out of which total 46 teams joined and participated in the competition. Each team had two Mooters and One Researcher i.e. 3 students.

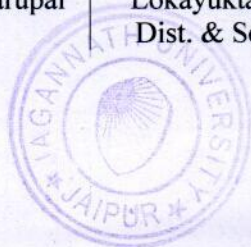

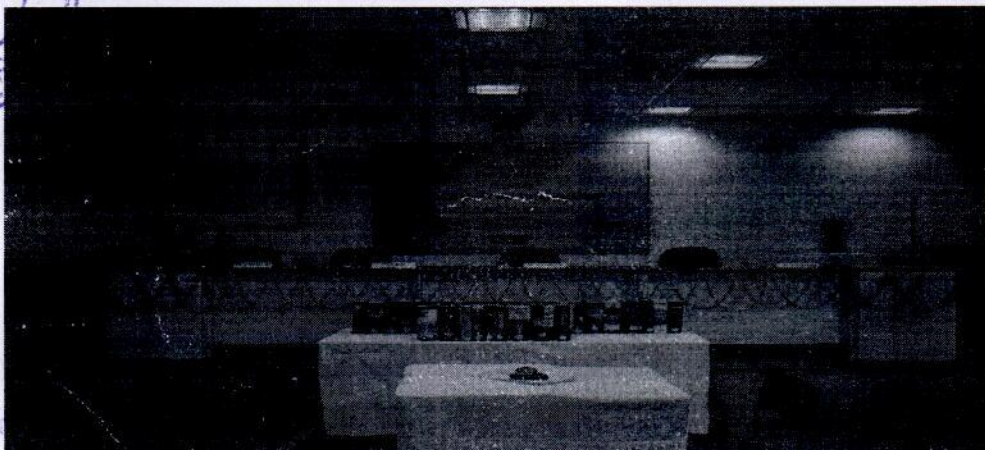

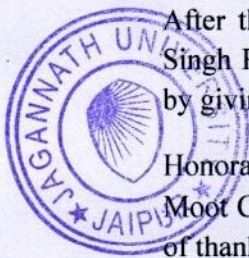
#### **INAUGURAL CEREMONY: 10:00 – 11:30 HRS**

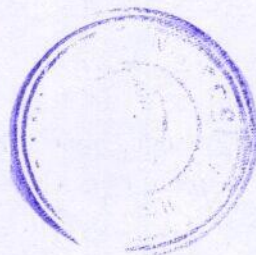

### PRELIMINARY ROUNDS: 11:30 – 14:30 HRS

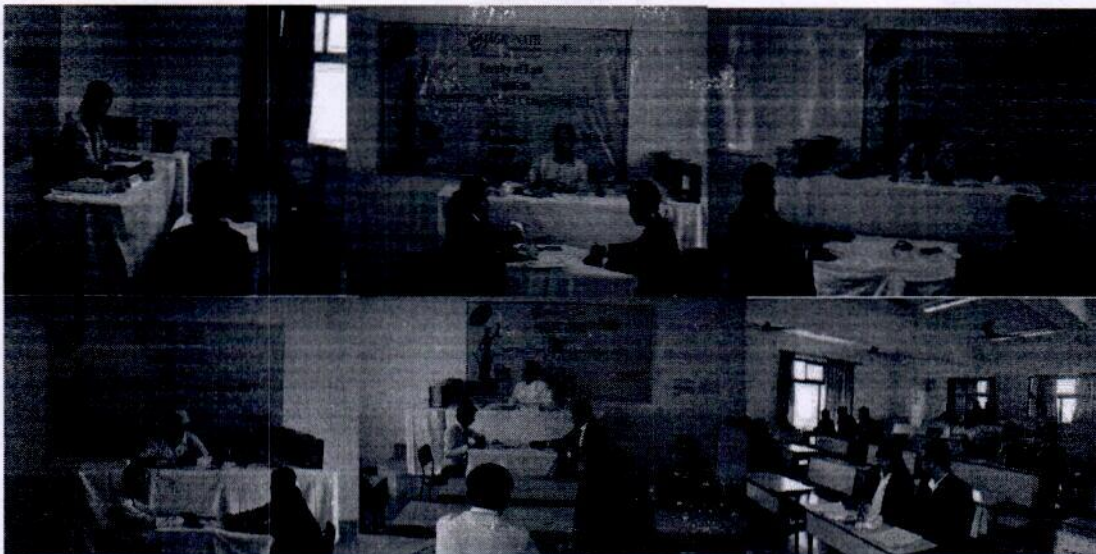

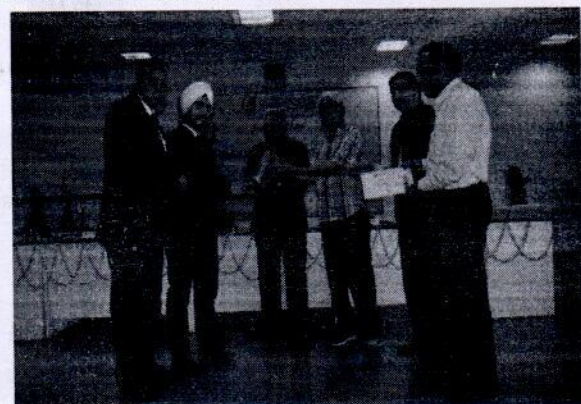
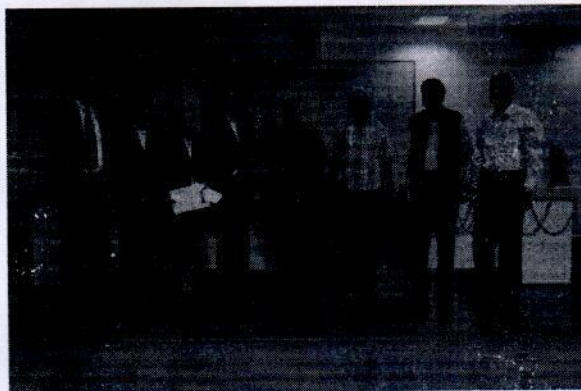

2. There should be two preliminary rounds, so that each participating team should get chance to present their arguments from both side i.e. appellant & respondent.
3. The memorial should be taken from both the side in 5-6 copies, so that they can easily distributed to judges also.

Participants also appreciated:

1. The overall management & discipline in organizing National Moot Court Competition.
2. The joint efforts of Dean, Faculty members and all the students involving in hospitality.
3. The Boarding, Transport and food provided to them.
4. The mechanism of draw of lots and result declaration pattern of each round of the competition.

**September 2019**

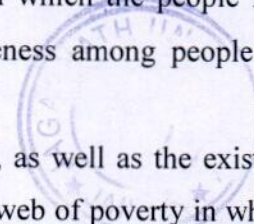
The camp—Legal Literacy Camp—was put up to spread information on programs sponsored by central government .Jagannath University Faculty of Law facilitated discussions and recorded the problems of villagers, relating to ineffective delivery of services. The villagers sought information and looked for the ways to get entitlements.

The camp provided information on Right to Education, National Food Security Act, Right to Information, Mahatma Gandhi National Rural Employment Guarantee Act (MNREGA), Integrated Child Development Services, Mid Day Meal, pension schemes (Old age and widow), and Panchayati Raj Institutions. In addition, it facilitated the process of seeking legal assistance by writing applications and complaints on behalf of villagers to make public services accessible to all. The camp further provided an opportunity for villagers to interact with the Faculties and Students of Legal Aid Committee of the Jagannath University. *Sarpanch* , village council head and two nearby villages addressed the queries of villagers and verified their pension applications on the spot, the legal literacy camp at [the adopted Village by the University] Rampura and ThikariaStudents and Faculties did a commendable job in inching closer to empowering local communities in These villeges.

The camp provided adequate knowledge and information about the rights and entitlements under the various centrally sponsored government programs. The efforts gained prominence under the light that “About 70% of the people in India live in rural areas and most of them are illiterate. A substantial number of people are not aware of their rights conferred by law... It is this absence of legal awareness which is responsible for deception, exploitation, and deprivation of rights and benefits, making people suffer in Villages. The miserable condition in which the people find themselves can be alleviated to some extent by creating legal awareness among people.” – Rajasthan Legal Services Authority.

“Lack of awareness on legal and constitutional rights and entitlements, as well as the existing accountability mechanisms is a major bottleneck responsible for the cobweb of poverty in which the rural citizens are wedged. The poor conditions to which they are subjected stem from
