
Agenda Item 2.4: To discuss the modality to assist the Alumni Cell in preparing first E-Alumni Magazine.

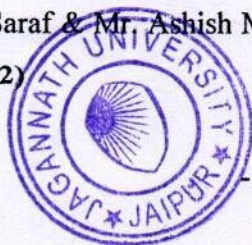

Agenda Item No. 1.3 : To discuss the objectives of the Association.



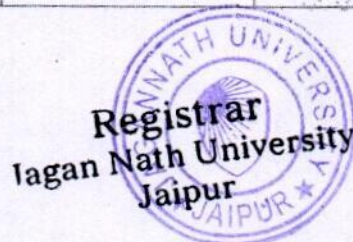

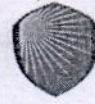
