As per the requirement of this Programme, following UBA Cell is constituted to undertake various developmental activities in these villages:



Please accept my greetings on the occasion of Deepawali !

As you are aware, that UGC and MHRD have taken various initiatives for improving Quality Research and Innovation in Higher Education. MHRD Innovation Cell (MIC) has been established by MHRD to foster the culture and innovation within Higher Education Institutions (HEIs).

The primary mandate of MIC is to encourage, inspire and nurture young students to work on new ideas. MIC has envisioned creation of "Institution's Innovation Council (ICs)" across selected HEIs. A network of these ICs will be established to promote innovation in the Institution through multitudinous modes leading to an innovative eco-system in the campuses. So far, 800 HEIs have complied by registering online however, most of them are from Engineering, Technology and such other professional institutions.

Although, it was resolved in the National Conference of Vice-Chancellors on 27th July, 2018 to create an innovation eco-system where culture of research is ingrained for all, hardly 96 universities have registered so far for establishment of IIC. 
