- 2. They shall be given admission provisionally subject to the verification of the documents.
- 3. They are required to submit the original as well as self attested copies of the following certificates:
 - (i) Certificates of Board of Secondary Education (for verification of Date of Birth)
 - (ii) Degree of Post Graduation (in the subject in which candidate wish to pursue the PhD) and Graduation.
 - (iii) Detailed marks sheets of the Post Graduation and Graduation at the time of depositing the fee.

- 5. After qualifying Ph. D. Course work candidate shall be registered in the Ph.D. Programme and they will be required to deposit the fee of Rs. 1,15,000/- per annum.
